CONDITIONS FOR PNG TRADING ROOM – ROSEMONT, IL – AUGUST 14, 2022

- 3) Although security will be furnished for the bourse area, the presence of security personnel or security systems does not constitute a guarantee against loss, or a policy of insurance, or a promise to indemnify in the event of loss by fire, theft or other casualty. Applicant is expected to insure himself against any loss he or she might sustain, if he or she desires such protection.
- 4) Any applicant who has made false statements concerning his employees, family members or assistants will be subject to disciplinary action, and the person about whom a false statement is made may be banned from the bourse floor.
